Terms of Reference of Audit Committee

- 1. Overseeing the Company's financial reporting process, examination of the financial statement and the auditors' report thereon and the disclosure of its financial information to ensure that the financial statement is correct, sufficient and credible; 2.
- Recommendation to the Board for appointment, re-appointment, replacement, remuneration and terms of appointment of auditors of the Company including the internal auditor, cost auditor and statutory auditor of the Company, and fixation of the audit fee; 3.
- Approval of payment to statutory auditors for any other services rendered by the statutory auditors;
- Reviewing, with the management, the annual financial statements and auditor's report thereon before 4. submission to the Board for approval, with particular reference to:
- Matters required to be included in the director's responsibility statement to be included in the Board's (a) report in terms of clause (c) of sub-section (3) of Section 134 of the Companies Act, 2013; (b)
- Changes, if any, in accounting policies and practices and reasons for the same;
- Major accounting entries involving estimates based on the exercise of judgment by management; (c) (d)
- Significant adjustments made in the financial statements arising out of audit findings; (e)
- Compliance with listing and other legal requirements relating to financial statements; (f)
- Disclosure of any related party transactions; and
- Modified opinion(s) in the draft audit report; (g)
- Reviewing, with the management, the quarterly financial statements before submission to the Board for 5. 6.
- reviewing, with the management, the statement of uses / application of funds raised through an issue (public issue, rights issue, preferential issue, etc.), the statement of funds utilized for purposes other than those stated in the offer document / prospectus / notice and the report submitted by the monitoring agency monitoring the utilisation of proceeds of a public or rights issue, and making appropriate recommendations to the Board to take up steps in this matter;
- Reviewing and monitoring the auditor's independence and performance, and effectiveness of audit 7. 8.
- Formulating a policy on related party transactions, which shall include materiality of related party
- Approval or any subsequent modification of transactions of the Company with related parties; All related 9. party transactions shall be approved by only Independent Directors who are the members of the committee and the other members of the committee shall reuse themselves on the discussions related to

- Review, at least on a quarterly basis, the details of related party transactions entered into by the Company 10. pursuant to each of the omnibus approvals given; 11.
- Scrutiny of inter-corporate loans and investments;
- Valuation of undertakings or assets of the Company, wherever it is necessary; Appointment of Registered 12. Valuer under Section 247 of the Companies Act, 2013. 13.
- Evaluation of internal financial controls and risk management systems; 14.
- Reviewing, with the management, performance of statutory and internal auditors and adequacy of the

- Reviewing the adequacy of internal audit function, if any, including the structure of the internal audit 15. department, staffing and seniority of the official heading the department, reporting structure coverage and frequency of internal audit; 16.
- Discussion with internal auditors of any significant findings and follow up thereon; 17.
- Reviewing the findings of any internal investigations by the internal auditors into matters where there is suspected fraud or irregularity or a failure of internal control systems of a material nature and reporting
- Discussion with statutory auditors before the audit commences, about the nature and scope of audit as 18. well as post-audit discussion to ascertain any area of concern;
- to look into the reasons for substantial defaults in the payment to the depositors, debenture holders, 19. shareholders (in case of non-payment of declared dividends) and creditors; 20.
- To review the functioning of the whistle blower mechanism;
- Approval of appointment of chief financial officer (i.e., the whole-time finance director or any other 21. person heading the finance function or discharging that function) after assessing the qualifications, experience and background, etc. of the candidate; 22.
- Carrying out any other function as is mentioned in the terms of reference of the audit committee; and
- Reviewing the utilization of loans and/ or advances from/investment by the holding company in the 23. subsidiary exceeding rupees 100 crore or 10% of the asset size of the subsidiary, whichever is lower including existing loans / advances / investments existing as on the date of coming into force of this
- To formulate, review and make recommendations to the Board to amend the Terms of Reference of Audit 24. Committee from time to time; 25.
- Establishing a vigil mechanism for directors and employees to report their genuine concerns or 26.
- Reviewing the utilization of loans and/or advances from/investment by the Company in the subsidiaries exceeding rupees 100 crore or 10% of the asset size of the subsidiary, whichever is lower including existing loans / advances / investments existing as on the date of coming into force of this provision;
- The Audit Committee shall review compliance with the provisions of the SEBI Insider Trading 27. Regulations, at least once in a financial year and shall verify that the systems for internal control under the said regulations are adequate and are operating effectively;
- to consider the rationale, cost benefits and impact of schemes involving merger, demerger, amalgamation 28. etc. of the Company and provide comments to the Company's shareholders; and
- Carrying out any other functions as provided under the provisions of the Companies Act, the SEBI Listing 29. Regulations and other applicable laws, and carrying out any other functions as may be required / mandated and/or delegated by the Board as per the provisions of the Companies Act, 2013, SEBI Listing Regulations, uniform listing agreements and/or any other applicable laws or by any regulatory authority and performing such other functions as may be necessary or appropriate for the performance of its duties.

The Audit Committee shall mandatorily review the following information:

- Management discussion and analysis of financial condition and results of operations; 1. 2.
- Statement of significant related party transactions (as defined by the audit committee), submitted by 3.
- Management letters / letters of internal control weaknesses issued by the statutory auditors; 4.
- Internal audit reports relating to internal control weaknesses; and
- The appointment, removal and terms of remuneration of the chief internal auditor shall be subject to 5. review by the audit committee.

The powers of the Audit Committee shall include the following:
